# 1. Introducing RP-600 PG2

The RP-600 PG2 is a range extender designed to relay digital data between wireless PowerG control panel devices and a PowerG control panel. Repeaters are required when the control panel is beyond the range of at least some of the devices and is therefore incapable of receiving transmissions directly.

### 2. Mounting the Device

Press the self-test button once and release it. The rec LED and then the green LED switches ON and then arrow button or type the zone number and then OFF to indicate that the repeater is now fully operational. After 2 seconds the LED blinks 3 times.
